Attached is an English translation of the summary of the letter dated July 13, 2009, filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*:

By letter dated July 13, 2009, the Company reported that it has acquired to Cactus Feeders Inc., directly and indirectly 6,589,335 common shares of *Cactus Argentina S.A.*, and directly 120,000 common shares of *Exportaciones Agroindustriales Argentinas S.A.*. The total acquisition amount for both transactions was U\$S 2,400,000.

Simultaneously the Company and Tyson Foods S.A., made capital contributions to *Cactus Argentina S.A.*, directly and indirectly for the sum of U\$S 2,363,077 and U\$S 2,560,000 respectively.

Therefore, given this acquisitions, the Company's interest in both companies reached 48%. providing financial strengthening to both companies trough the aforementioned capital contributions and favoring to accomplish the Company's strategic business plan.
