#### Introduction

This Amendment No. 2 (Amendment No. 2) amends and supplements the Schedule 13D filed with the Securities and Exchange Commission (the SEC) on October 7, 2010, as amended by Amendment No. 1 thereto filed with the SEC on October 21, 2010 (such Schedule 13D, as amended, the Schedule 13D) on behalf of (i) Seneca Capital International Master Fund, L.P., a Cayman Islands exempted limited partnership (International Fund), (ii) Seneca Capital, L.P., a Delaware limited partnership (U.S. Fund), (iii) Seneca Capital Investments, L.P., a Delaware limited partnership (Seneca LLC), (v) Seneca Capital International GP, LLC, a Delaware limited liability company (Seneca LLC), (v) Seneca Capital International GP, LLC, a Delaware limited liability company (Seneca Advisors), and (vii) Douglas A. Hirsch (together with each of the foregoing, the Reporting Persons), with respect to shares of Common Stock, par value \$0.01 per share (Common Stock), of Dynegy Inc., a Delaware corporation (the Issuer), beneficially owned by the Reporting Persons (the Shares). Capitalized terms used and not otherwise defined in this Amendment No. 2 shall have the meanings previously ascribed thereto in the Schedule 13D.

Amendment No. 2 is filed to amend Item 4 of the Schedule 13D as set forth below.

#### Item 4. Purpose of Transaction

Item 4 is hereby amended to restate the second paragraph of Item 4, as initially filed, as follows:

The Reporting Persons intend to review their investments in the Issuer from time to time and have contemplated and reserve the right to implement plans or proposals with respect to the Issuer as a means of enhancing shareholder value, whether alone or with third parties. Specifically, the Reporting Persons are considering a proposal to replace two members of the Issuer s Board of Directors and proposals for stockholder resolutions encouraging the Issuer s Board of Directors to enhance stockholder value. In addition, the Reporting Persons are exploring the potential for alternative transactions to the Proposed Merger. Action taken by the Reporting Persons could include one or more purposes, plans or proposals that relate to or would result in actions required to be reported herein in accordance with Item 4 of Schedule 13D.
