On December 9, 2010, The Mosaic Company announced its plans to redeem the remaining \$455 million aggregate principal amount of its 7-3/8% senior notes due December 2014 (the Notes ) pursuant to the terms of the Indenture dated as of December 1, 2006 relating to the Notes. A copy of the press release announcing the redemption of the Notes is attached hereto as Exhibit 99.1.

The Notes are being redeemed on January 13, 2011 at a price of \$1,036.88 per \$1,000 principal amount, together with interest accrued and unpaid to the redemption date of \$8.6042 per \$1,000 in principal amount of the Notes.
