The Company expects a significant change in the consolidated results of operations from the corresponding period for the last fiscal year. Operating revenues increased approximately 31% primarily due to increased oil & natural gas prices received, while operating expenses decreased approximately 8% primarily due to decreased depreciation, depletion and amortization. Therefore, we expect the results for the year ended December 31, 2010 to reflect net income while the year ended December 31, 2009 reflected a net loss of \$23.679 million.
