Introductory Statement

This Amendment No. 2 (the Amendment) amends and supplements the Tender Offer Statement on Schedule TO originally filed with the Securities and Exchange Commission (SEC) on June 1, 2011 (the Schedule TO) and amended on July 1, 2011, by The Swiss Helvetia Fund, Inc., a Delaware corporation (the Fund), pursuant to Rule 13e-4 under the Securities and Exchange Act of 1934, as amended (the Exchange Act), in connection with the Fund s offer to repurchase up to 1,530,131 of its issued and outstanding shares of common stock, par value \$0.01 per share, upon the terms and subject to the conditions contained in the Offer to Repurchase, dated June 1, 2011, and the related Letter of Transmittal (which, together with any amendments or supplements thereto, collectively constitute the Offer to Repurchase), at a purchase price equal to 98% of the Fund s net asset value (NAV) per share, as determined as of July 1, 2011. The Fund s NAV is calculated daily by 6:15 p.m. Eastern Time, and generally by 4:45 p.m. Eastern Time on each day during which the New York Stock Exchange is open for trading.

This Amendment is intended to satisfy the reporting requirements of Rule 13e-4(c)(3) promulgated under the Exchange Act.
