**EXPLANATORY NOTE**

Pursuant to General Instruction E of Form S-8, the Registrant hereby makes the following statements: On April 2, 2007, the Registrant filed a Registration Statement on Form S-8 (Registration Statement No. 333-141814) (the 2007 Registration Statement ), to register 1,140,000 shares of the Registrant's common stock, \$0.0001 par value (the Common Stock ), for issuance under the Hill International, Inc. 2006 Employee Stock Option Plan, as amended (the Plan ). On November 13, 2008, the Registrant filed a Registration Statement on Form S-8 (Registration Statement No. 333-155332) (the 2008 Registration Statement ) to register 1,860,000 additional shares of Common Stock for issuance under the Plan. On June 6, 2011, the Registrant filed a Registration Statement on Form S-8 (Registration Statement No. 333-174737) (the 2011 Registration Statement ) and, collectively with the 2007 Registration Statement and the 2008 Registration Statement, the Prior Registration Statements ) to register 3,000,000 additional shares for issuance under the Plan. The contents of the Prior Registration Statements are incorporated by reference into this Registration Statement. The Registrant is now filing this Registration Statement to register an additional 2,000,000 shares of Common Stock that may be issued under the Plan pursuant to amendments to the Plan authorized by the stockholders of the Registrant on June 11, 2012.
