Subject: American and US Airways Receive Request for Additional Information from DOJ

Summary

As part of our proposed merger, American and US Airways received a request for additional information from the U.S. Department of Justice (DOJ). A second request is a routine part of the Hart Scott Rodino merger review process and we are working cooperatively with the DOJ as it continues its review of our proposed merger.

This request will likely result in questions from your people, and we want to be sure you have the facts to share.

Key Points

A second request simply means the DOJ requires more information from us to complete its regulatory review and extends the waiting period for HSR clearance until 30 days after we substantially comply with that request.

A second request is routine and is something we anticipated when we announced the combination. In fact, all three of the previous airline mergers in the U.S. received second requests for more information.

We are working cooperatively with the DOJ as it continues its review of our proposed merger and we continue to expect the combination to be completed in the third quarter of 2013.

The HSR Act provides that parties must not complete certain mergers, acquisitions or transfers of securities or assets until they have made a detailed filing with the U.S. Federal Trade Commission and Department of Justice and waited for those agencies to determine that the combination will not adversely affect U.S. commerce under the antitrust laws (that is, the provision is used to explore if a merger or acquisition will discourage competition in any way).
