**Item 7.01. Regulation FD Disclosure.**

On March 17, 2014, Casey's General Stores, Inc. (the Company) reported February 2014 same-store sales results for stores open for one full year. Same-store sales for prepared food and fountain increased 12.1%, and grocery and other merchandise increased 6.6% in February 2014 compared to February 2013.

Same-store gasoline gallons sold increased 4.0% in February 2014 compared to February 2013. The gasoline margin was below the Company's fiscal 2014 goal of 15.0 cents per gallon. The average retail price of gasoline sold during February 2014 was \$3.22 per gallon.
