PEP GP is the general partner of PEP VI, PEP VI-A and PEP Co-Investor. PEP LLC is the general partner of PEP GP. Glenn M. Creamer, Jonathan M. Nelson and Paul J. Salem are members of PEP LLC. As a result of these relationships, each of PEP GP, PEP LLC, Creamer, Nelson and Salem has shared voting and dispositive power with respect to the shares of Common Stock directly held by PEP VI, PEP VI-A and PEP Co-Investor.
- (b) In the aggregate, the Reporting Persons beneficially own 23,592,886 shares of Common Stock, or 13.7% of the total number of shares of Common Stock outstanding, by virtue of the 14,948,294 shares of Common Stock directly held by PEP VI, the 5,142,393 shares of Common Stock directly held by PEP VI-A and the

3,502,199 shares of Common Stock directly held by PEP Co-Investor.
