In connection with Mr. Jimmerson's decision to step down as CFO of the Company, the Company has agreed to amend Mr. Jimmerson's employment agreement to provide for a \$1,000,000 severance payment if Mr. Jimmerson will remain with the Company to help identify, retain and transition to a new Chief Financial Officer until the earlier of the completion of such transition or December 31, 2015.
