Item 1. Description of Registrant's Securities to be Registered

This Form 8-A is being filed in connection with Hercules Capital, Inc.'s, a Maryland corporation (the **Registrant**), offering of its 5.25% Notes due 2025 (the **2025 Notes**). The 2025 Notes are expected to be listed on the New York Stock Exchange and to trade thereon on or around April 26, 2018 under the trading symbol HCXZ. As of April 26, 2018, the Registrant had sold and issued \$75,000,000 in aggregate principal amount of the 2025 Notes and granted an over-allotment option of up to \$11,250,000 in aggregate principal amount of the 2025 Notes.

The description of the 2025 Notes is incorporated herein by reference to the information set forth under the heading "Description of Our Debt Securities" in the Registrant's Prospectus included in the Registration Statement on Form N-2 (Registration No. 333-214767) as filed with the Securities and Exchange Commission (the **SEC**) on September 5, 2017 under the Securities Act of 1933, as amended (the **Securities Act**), and the information under the heading "Specific Terms of the Notes and the Offering" in the Registrant's Prospectus Supplement dated April 23, 2018, as filed with the SEC on April 24, 2018 pursuant to Rule 497 under the Securities Act. The foregoing Prospectus and Prospectus Supplement are incorporated herein by reference.
