Novo Nordisk A/S – Share repurchase programme

On 11 August 2011 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 2.1 billion in the period from 11 August 2011 to 25 October 2011.

Since the announcement as of 22 August 2011, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 19,231,697 treasury shares, corresponding to 3.3% of the share capital. The total amount of shares in the company is 580,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares worth DKK 10.0 billion during 2011. As of 26 August 2011, Novo Nordisk has repurchased a total of 12,112,053 B shares equal to a transaction value of DKK 7,371,926,666.
