The units were acquired on April 1 pursuant to a quarterly automatic grant. On March 30, 2005, Harris Corporation distributed a stock dividend, payable to all holders of record of common stock on March 14, 2005, of 1 share of common stock for each share of common stock outstanding. The aggregate of 2,757.86 phantom stock units includes phantom units acquired on 3/30/05 as a result of the 2-for-1 split and 10.38 units acquired through dividend reinvestment in the Harris Corporation 1997 Directors' Deferred Compensation and Annual Stock Unit Award Plan from 3/4/04 through 11/17/04 and the Harris Corporation 2005 Directors' Deferred Compensation Plan on 3/10/05.
