The reporting person holds previously reported options to buy 19,757 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 1994 Performance Plan and the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between February 5, 2003 and March 2, 2005, at exercise prices between \$22.68 to \$47.01 per share, will expire between February 5, 2013 and March 2, 2015 and became or will become exercisable between December 31, 2003 and March 31, 2009.
