Of the 23,374,450 shares of Class B common stock reported in Table 1, (A) Mr. Norniella beneficially owns 671 shares of Class B common stock, all of which were redeemed by the Company on February 24, 2006 and (B) Coinmach Holdings, LLC ("Holdings") (1) beneficially owns 23,373,779, all of which beneficial ownership Mr. Norniella disclaims, except to the extent of any pecuniary interest therein. Mr. Norniella owns less than 1% of the outstanding Common Units and less than 1% of the outstanding Class C Preferred Units of Holdings.

Mr. Norniella is the President and Secretary of Appliance Warehouse of America, Inc. Mr. Norniella is also the Senior Vice President of Coinmach Corporation.
