(1) The Form 3 filed on May 15, 2006 reported ownership of 56,682 shares of common stock, which was the number of shares covered by a restricted stock grant under the issuer's Equity Participation Plan. Accordingly, this Form 3/A amends the Form 3 filed on May 15, 2006 to report that the amount of securities owned should be 36,021 shares of common stock.
