All of the shares are subject to the Company's repurchase option upon the occurrence of certain events and may not be disposed of prior to 10/2/2010, other than upon the occurrence of certain events.

(2) Non-Qualified Stock Option in respect of shares of common stock granted under the 2005 Performance Plan of The Goodyear Tire & Rubber Company. The option permits the optionee to purchase the option shares with previously owned shares (at their market value on the date of exercise) and to satisfy withholding tax obligations by requesting the Issuer to withhold option shares to cover such taxes or with previously owned shares (at market value at exercise).

(3) The option vests and becomes exercisable in 25% increments over four years commencing one year after the date of grant.
