- (1) The stock options become exercisable in three equal annual installments beginning on February 14, 2009.
- (2) The stock units convert to ConocoPhillips common stock on a 1-for-1 basis.
The stock units will be forfeited if the reporting person separates from service prior to the end of an escrow period ending on the earliest to occur of the following: (a) termination of employment as a result of layoff; (b) termination of employment after attainment of age 55 with five years of service; (c) termination of employment due to death; (d) termination of employment following disability; or (e) termination of employment following a change in control. During the escrow period, the reporting person may not dispose of the stock units. The stock units will convert to common stock on the later of (a) the end of the escrow period and (b) the earlier of death or six months after separation from service. The reporting person may also elect to defer conversion of the stock units until a later date.
- (4) The stock units do not have an expiration date.
