*Previous filings for Invesco Van Kampen California Value Municipal Income Trust were made under Van Kampen California Value Municipal Income Trust (VCV); the name change resulted from the completion of Invesco Ltd's acquisition of Morgan Stanley's retail asset management business, including Van Kampen Investments, on June 1, 2010.

The Shares reported herein represent UBS AG's combined holdings in multiple series of auction preferred securities of the issuer. These securities are treated herein as one class of securities in accordance with the Auction Rate Securities -- Global Exemptive Relief letter ("Global Relief Letter") issued by the staff of the Securities and Exchange Commission (SEC) on September 22, 2008.
