*Previous filings for Invesco Van Kampen Pennsylvania Value Municipal Income Trust were made under Van Kampen Pennsylvania Value Municipal Income Trust (VPV); the name change resulted from the completion of Invesco Ltd's acquisition of Morgan Stanley's retail asset management business, including Van Kampen Investments, on June 1, 2010.

The Shares reported herein represent UBS AG's combined holdings in multiple series of auction preferred securities of the issuer.
