 - (1) Represents shares issued under the 2007 Stock Incentive Plan pursuant to the terms of the 2012 Realogy Executive Incentive Plan, as amended ("EIP"), prior to the withholding of shares to pay applicable withholding taxes described in footnote (2). Reporting Person received 11/12ths of total payment under the EIP, with the balance payable in cash in March 2013 and subject to adjustment based upon full year 2012 audited results. Bonus was above target and pursuant to the EIP, Reporting Person received 50% of December 2012 payment in stock. Because performance achieved was above target, the number of shares received was equal to the product of 1.2 multiplied by the quotient equal to dollar amount of the bonus payable in December 2012 divided by the closing sale price of the common stock on December 19, 2012.
 - (2) These shares were withheld in order to pay applicable withholding taxes upon issuance of shares described in footnote (1).
