(1) Grant of Restricted Stock.

Each performance unit represents a contingent right to receive one share of the company's common stock. 32,792 performance units were forfeited in January 2013 as the performance conditions governing the awards were not met. The remaining performance units vest 1/2 each in January 2014 and January 2015 based on the company's total stockholder return performance relative to a selected peer group for the two years ended December 31, 2013 and three years ended December 31, 2014, respectively. The performance units reported represent target performance. The maximum number of performance units which may be earned is 131,168 performance units, and the minimum number of performance units which may be earned is zero (0) performance units.

(2) Each performance unit represents a contingent right to receive one share of the company's common stock. The performance units vest 1/2 each in January 2015 and January 2016 based on the company's total stockholder return performance relative to a selected peer group for the two years ended December 31, 2014 and three years ended December 31, 2015, respectively. The performance units reported represent target performance. The maximum number of performance units which may be earned is 200,520 performance units, and the minimum number of performance units which may be earned is zero (0) performance units.
