Common Stock, immediately upon vesting which vesting is scheduled to occur in annual installments (assuming continued employment).
 - (2) Each restricted stock unit (RSU) represents a contingent right to receive one share of Cohu, Inc. Common Stock upon vesting. The RSU vests in four equal annual installments beginning March 26, 2013 (assuming continued employment).
