(1) In September 5, 2013, the reporting person gifted without the receipt of consideration 20,000 shares of Virtusa common stock to the Moriarty Family Charitable Trust.

The reporting person hereby undertakes to provide upon request to the SEC staff, the issuer or a security holder of the issuer full information regarding the number of shares and prices at which the transaction was effected

(5) The reporting person is the Chief Investment Officer and Managing Member of Rubex, LLC, a limited liability company.
