The reporting person may receive a number of shares of PepsiCo Common Stock from 0% to 175% of the PEPunits granted, depending on the level of performance achieved.
- (3) Reflects the number of shares held under the reporting person's account in the PepsiCo Savings Plan as of February 28, 2014.
 - (4) These phantom units are held under the PepsiCo Executive Income Deferral Program and convert to shares of PepsiCo Common Stock on a one-for-one basis.
 - (5) This amount relates to dividends credited to the reporting person's phantom stock account on various dates between March 12, 2013 and February 28, 2014 pursuant to PepsiCo's Executive Income Deferral Program, at prices ranging from \$76.15 to \$86.80.
 - (6) This security is payable pursuant to the reporting person's election and the terms of PepsiCo's Executive Income Deferral Program.
