- (1) The Company completed a one-for-seven reverse stock split effective May 16, 2014. The amount stated represents the post-split adjusted amount, and fractional shares are not included because all fractional shares were aggregated into whole shares and sold on the open market at prevailing prices by the Company's transfer agent. In lieu of fractional shares, the reporting person received a cash payment equal to his or her allocable share of the total proceeds of these sales.
 - (2) The reporting person's previous Form 4 dated August 13, 2014 inadvertently overstated the reporting person's beneficial stock ownership by failing to account for the reverse stock split, as described above.
 - (3) As adjusted post-split, as described above.
