(1) Represents 5% vesting on Saturday, August 1, 2015, with a release date of Monday, August 3, 2015, the first business day following the vesting. The original grant was 79,916 restricted stock units, with 20% vesting on November 1, 2014, and the remaining 80% vesting in equal quarterly installments over the remaining 4 years.

(2) Each restricted stock unit represents the right to receive, following vesting, one share of Pegasystems Inc.'s common stock.
