On July 6, 2015, the Reporting Person was granted 100,000 Restricted Stock Units ("RSUs") under the Amarin Corporation plc 2011 Stock Incentive Plan (the "Plan"). These RSUs commence vesting upon achievement of certain performance criteria and continued employment of the Reporting Person as provided in the Restricted Stock Unit Award Agreement between the Issuer and the Reporting Person. On October 5, 2015, the performance criteria was deemed to have been achieved, resulting in the vesting of 6,250 RSUs. The remaining RSUs will vest in 15 quarterly installments.
