- (1) Effective November 1, 2018, the Company granted 1,025 restricted stock units as an annual grant to non-employee directors, valued at the then current market price of \$126.82 per share. Such shares vest on October 31, 2019 unless, with certain exceptions, the reporting person ceases to be a director prior to the vesting date. The total holdings include 8 shares accrued from dividend payments through participation in the Directors Deferred Compensation Plan and pursuant to the Company's Dividend Reinvestment Plan.
