- b) declared a dividend for the the first quarter ending March 31, 2013, of \$0.5344 per diluted share, for the Company’s 8.55% Series A Cumulative Preferred Stock. This dividend is payable April 15, 2013, for shareholders of record as of March 29, 2013.
- c) declared a dividend for the the first quarter ending March 31, 2013, of \$0.5281 per diluted share, for the Company’s 8.45% Series D Cumulative Preferred Stock. This dividend is payable April 15, 2013, for shareholders of record as of March 29, 2013.
- d) declared a dividend for the first quarter ending March 31, 2013, of \$0.5625 per diluted share, for the Company’s 9.00% Series E Cumulative Preferred Stock. This dividend is payable April 15, 2013, for shareholders of record as of March 29, 2013.
