- (1) The terms of these outstanding phantom units have been modified, resulting in the deemed cancellation of the original phantom units and a grant of replacement phantom units described below. The original phantom units were granted on November 2, 2010.
- (2) One Common Unit is deliverable, upon vesting, for each phantom units that vests.  
As modified, these phantom unit awards will vest 30% on the date the Issuer pays an annualized distribution of \$1.45 per unit; 30% on the date the Issuer pays an annualized distribution of \$1.50 per unit; and 40% on the date the Issuer pays an annualized distribution of \$1.55 per unit. Fifty percent of any unvested phantom units that remain outstanding as of the November 2016 distribution date will vest on such date and the remaining 50% will be forfeited.
- (3) As modified, 100% of these phantom units will vest upon conversion of the Issuer's Series A Subordinated Units into Common Units.
- (4) Conversion of the Series A Subordinated Units is subject to certain performance conditions set forth in the Issuer's Second Amended and Restated Agreement of Limited Partnership, as amended.
