Accenture SCA may, at its option, pay the redemption price with cash or by delivering Accenture Ltd Class A common shares.

(2) Options with respect to 10,933 underlying shares vested and became exercisable prior to September 1, 2006. The remaining 5,648 vest and become exercisable on August 31, 2007.

(3) 100% vested and exercisable prior to September 1, 2006.
