Entry into a Material Definitive Agreement.

On June 18, 2007 the Registrant received an executed amendment number 3 to Contract No. FAR001, between the State of Florida, Agency for Healthcare Administration and HealthEase of Florida, Inc. (Medicaid Reform 2006-2009), a wholly-owned subsidiary of the Registrant, and an executed amendment number 3 to Contract No. FAR009, between the State of Florida, Agency for Healthcare Administration and WellCare of Florida, Inc. d/b/a Staywell Health Plan of Florida (Medicaid Reform 2006-2009), also a wholly-owned subsidiary of the Registrant.
