(1) The sales reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted on June 28, 2016.

The sale price reported in column 4 of Table I represents the weighted average sale price of the shares sold ranging from \$67.0811 to \$67.0826 per share.
