#### **GOL Announces Traffic Statistics for December 2004**

**São Paulo, January 6, 2005** GOL Linhas Aéreas Inteligentes S.A. (NYSE: GOL and Bovespa: GOLL4), Brazil s low-fare, low-cost airline, today released preliminary passenger statistics for the month of December 2004. The Company s market share in December 2004 increased 2.3 percentage points compared with the same period last year. Revenue passenger kilometers increased 23.2%, while load factor increased 3.0 percentage points.
