**Clarifications on exploration of the Ingre block in Bolivia**

(Rio de Janeiro, February 3, 2008). PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA, BCBA: APBR/APBRA], a Brazilian international energy company, in reply to official letter form CVM, on a report in a Brazilian newspaper on January 29 2009, wherein mention was made, among other information, that

*In Bolivia, Petrobras has found at a depth of 5,100 meters a layer of porous rock under which company experts believe there is a new and major natural gas reserve (...) the information was given to Valor by a Brazilian government official close to the state company s operations in Bolivia .*

The Company wishes to clarify that:

Petrobras has an exploratory project at the drilling phase in the Ingre block in the Bolivian department of Chuquisaca. Currently, no estimate can be made as to the existence or not of reserves of hydrocarbons and for this reason no estimates of potential volumes or a production timeframe are possible.
