- On December 31, 2011, 66,667 restricted stock units held by Mr. Morhaime vested. Pursuant to the terms of his restricted stock unit
- (1) award agreement, he elected to have the Company withhold 31,121 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.
 - (2) Following the receipt thereof, Mr. Morhaime transferred the net shares he received in connection with the vesting of his 66,667 restricted stock units to the Michael Morhaime Revocable Trust.
 - (3) Following the transactions reported on this Form 4, Mr. Morhaime directly held 449,999 restricted stock units, each representing the right to receive one share of the Company's common stock.
 - (4) Following the transactions reported on this Form 4, Mr. Morhaime (through the Michael Morhaime Revocable Trust) indirectly held 47,987 shares of the Company's common stock.
