On August 16, 2016, 1,693 restricted share units held by Mr. Zacconi vested. As allowed under the terms of his restricted share unit agreement, the Company withheld 796 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

On August 16, 2016, 5,344 restricted share units held by Mr. Zacconi vested. As allowed under the terms of his restricted share unit agreement, the Company withheld 2,512 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

The price in Column 4 is a weighted average price. The prices actually received for the stock ranged from \$39.34 to \$39.71 per share. Mr. Zacconi has provided to the Company and, upon request, will provide any security holder of the Company or the SEC staff with information regarding the number of shares sold at each price within that range.

Following the transactions reported on this Form 4, Mr. Zacconi held 70,379 restricted share units, each representing the right to receive a share of the Company's common stock.

The exercised options vested on August 16, 2016. The remaining options will be fully vested on February 16, 2019.
