- The shares of common stock of Apache are deemed to also represent certain preferred stock purchase rights ('Rights'). The Rights are not currently exercisable or separately tradable and presently are evidenced by certificates for shares of the common stock. Value attributable to such Rights, if any, is reflected in the market price of the common stock.
- (1) Vesting on 09/14/09 of restricted stock units granted to each of Apache's non-employee directors under 2007 Omnibus Equity Compensation Plan.
  - (2) The reporting person disclaims beneficial ownership of these securities, and this report shall not be deemed an admission that the reporting person is the beneficial owner of such securities for purposes of Section 16 or for any other purpose.
  - (3) With tandem tax withholding right
  - (4) One share of Apache common stock for each restricted stock unit.
  - (5) Vesting on 09/11/09 of restricted stock units under employer plan - data provided by plan administrator on 09/14/09. Vesting occurs 25% per year over four years.
  - (6) Restricted stock units granted to each of Apache's non-employee directors under 2007 Omnibus Equity Compensation Plan, which plan was approved by stockholders in May 2007. The units vest 50% thirty days after grant date and 50% twelve months after grant date.
