These options vest and become exercisable as follows: on each anniversary date of the grant, commencing with the first such anniversary date and continuing on each such anniversary thereafter through and including the fifth anniversary of the date of the grant, 20% of such options shall vest and become exercisable. The date of grant is 10 years prior to the stated expiration date.

- (1) These options vest and become exercisable as follows: on the third anniversary date of the grant, 60% of such options will vest and become exercisable; and on each of the fourth and fifth anniversary dates of the grant, 20% of such options will vest and become exercisable. The date of grant is 10 years prior to the stated expiration date.
- (2) Grant of Employee Stock Option (Right to Buy) on September 13, 2005 for 5,000 shares of ACS Class A Common Stock \$0.01 par value at an Exercise Price of \$52.99 per share. 2,000 shares have been exercised and 3,000 remain to be exercised.
- (3) Grant of Employee Stock Option (Right to Buy) on July 30, 2004 for 5,000 shares of ACS Class A Common Stock \$0.01 par value at an Exercise Price of \$51.90 per share. 3,000 shares have been exercised and 2,000 remain to be exercised.
- (4) As a result of an internal investigation of the Issuer's stock option grant practices, it was determined the accounting measurement date for certain stock option grants were incorrect. A part of this stock option grant has been repriced to reflect the fair market value of each share on the correct measurement date. The Reporting Person received a Grant of Employee Stock Option (Right to Buy) on July 21, 2003 for 5,000 shares of ACS Class A Common Stock \$0.01 par value at an Exercise Price of \$43.00 per share. 2,000 shares were exercised prior

to the repricing at the original Exercise Price of \$43.00 per share. The Exercise Price for 3,000 shares has been repriced at \$44.10 per share. 1,000 shares remain to be exercised.

- (6) As a result of an internal investigation of the Issuer's stock option grant practices, it was determined the accounting measurement date for certain stock option grants were incorrect. A part of this stock option grant has been repriced to reflect the fair market value of each share on the correct measurement date. The Reporting Person received a Grant of Employee Stock Option (Right to Buy) on July 23, 2002 for 5,000 shares of ACS Class A Common Stock \$0.01 par value at an Exercise Price of \$35.75 per share. 3,000 shares were exercised prior to the repricing at the original Exercise Price of \$35.75 per share. The Exercise Price for 2,000 shares has been repriced at \$37.57. This stock option grant has now been fully exercised.

- (7) As a result of an internal investigation of the Issuer's stock option grant practices, it was determined the accounting measurement date for certain stock option grants were incorrect. A part of this stock option grant has been repriced to reflect the fair market value of each share on the correct measurement date. The Reporting Person received a Grant of Employee Stock Option (Right to Buy) on January 29, 2002 for 5,000 shares of ACS Class A Common Stock \$0.01 par value at a post-split Exercise Price of \$44.925 per share. 3,000 shares were exercised prior to the repricing at the original Exercise Price of \$44.925 per share. The Exercise Price for 2,000 shares has been repriced at \$46.16 per share. This stock option grant has now been fully exercised.
