In October 2010, the Issuer entered into Debt Conversion Agreements with nine (9) creditors of the Issuer including Mr. Zaikin, the Issuer's Chief Executive Officer and Director, who converted \$1,153,228 of debt owed to him by the Issuer into 10,483,895 shares of (1) restricted common stock at the rate of one share for each \$0.11 of debt converted (the "Conversion"). The Conversion price of \$0.11 per share was calculated based on the average market price of the Issuer's common stock on the Over-The-Counter Bulletin Board for the six months prior to September 30, 2010.
