On March 25, 2015, the Company held its 2015 Annual Meeting of Shareholders. A total of 1,249,532 shares were represented in person or by valid proxy, and the shareholders voted on two proposals. The final results for the votes regarding each proposal are set forth below:

<u>Election of Directors</u>. The Company's shareholders elected five directors to serve until the next annual meeting of shareholders and the election of their successors. The number of votes cast for each of the directors is set forth below. There were 473,141 broker non-votes.

<u>Ratification of Independent Accountants</u>. The Company's shareholders ratified the appointment of BDO USA, LLP as the Company's independent registered public accounting firm for the current fiscal year. The vote totals were 1,219,495 FOR and 29,266 AGAINST, with 771 ABSTENTIONS.
