Item 7.01. Regulation FD Disclosure.

On February 10, 2016, GAIN Capital Holdings, Inc., a Delaware corporation (the “Company”), issued a press release to report certain operating metrics for the Company’s business for the month ended January 31, 2016. The full text of the press release is attached to this current report on Form 8-K as Exhibit 99.1.\* Please note that, due to a mathematical error, the number of Futures average daily contracts in the fourth bullet point under the heading "Retail Metrics" in the issued press release is mistakenly reported as 40,605 instead of 42,742. When comparing the number of Futures average daily contracts to prior periods, the percentage increases from December 2015 and January 2015 referenced in that bullet point should be 28.8% and 15.4% (rather than 22.4%, and 9.3%), respectively.
