#### ITEM 2.02. Results of Operations and Financial Condition.

On October 22, 2014, First Community Corporation (the "Company"), holding company for First Community Bank, issued a press release announcing its financial results for the period ended September 30, 2014. The Company announced that the Board of Directors has approved a cash dividend for the third quarter of 2014. The Company will pay a \$0.06 per share dividend to holders of the Company's common stock. This dividend is payable on November 14, 2014, to shareholders of record as of November 3, 2014.
