On August 10, 2018, Meredith Corporation issued a news release reporting results for the fourth fiscal quarter and full fiscal ended June 30, 2018. That news release is attached as an exhibit.

In the release as originally issued, the Company incorrectly stated its full-year fiscal 2019 expectations for earnings per share from continuing operations. Correctly stated, Meredith expects full-year fiscal 2019 earnings per share from continuing operations to range from \$2.78 to \$3.20. The attached release reflects this correction. No other information in the release, including the Fiscal 2019 Outlook, is impacted by this correction.
