This Amendment No. 13 to Schedule 13D is filed by each of Independence Holding Company, a Delaware corporation ("IHC"), Madison National Life Insurance Company, Inc., a Wisconsin corporation (Madison), and Madison Investors Corporation, a Delaware corporation ("MIC"), pursuant to Rule 13d-2(a) under the Securities Exchange Act of 1934, as amended. This Amendment No. 13 to Schedule 13D amends and supplements the Schedule 13D (as previously amended, the Schedule 13D) originally filed with the Securities and Exchange Commission on August 8, 2002 relating to the common stock, par value \$0.01 per share (Common Stock), of American Independence Corp., a Delaware corporation (the Company).

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 of the Schedule 13D is hereby amended to add the following to the end thereof:

Pursuant to a public exchange tender offer, on August 15, 2011, IHC acquired a total of 1,109,225 shares of Common Stock in consideration of an aggregate 693,228 newly issued shares of IHC common stock, par value \$1.00 per share, plus a *de minimis* amount of cash paid *in lieu* of fractional shares.

Item 4. Purpose of Transaction.

Item 4 of the Schedule 13D is hereby amended to add the following to the end thereof:

IHC acquired beneficial ownership of the shares of Common Stock to which the most recent amendment to this Schedule 13D relates for investment purposes and to increase its equity interest in the Company.

Item 5. Interest in Securities of the Issuer.

Paragraph (a) of Item 5 of the Schedule 13D is hereby amended to add the following to the end thereof:

On September 1, 2011, IHC and its direct and indirect subsidiaries, collectively, beneficially owned an aggregate of 6,474,051 shares of Common Stock, representing approximately 75.95% of the outstanding shares of Common Stock,

based upon the 8,523,702 shares of Common Stock of the Company issued and outstanding as of July 13, 2011. Of such 6,474,051 shares of Common Stock, pursuant to Rule 13d-4 promulgated under the Securities Exchange Act of 1934, as amended, IHC disclaimed beneficial ownership as to the shares owned by its indirect, wholly owned subsidiary, as follows: 4,464,501 shares owned by MIC.

Paragraph (c) of Item 5 of the Schedule 13D is hereby amended to add the following to the end thereof:

Other than as reported by this Schedule 13D, no person reporting hereunder has effected any transaction in shares of Common Stock during the sixty days preceding the date of the most recent amendment hereto.
