Explanation of Responses:

- (1) This filing amends the original Form 4 filed on September 17, 2006, which inadvertently reflected the vesting of phantom stock units. The stock which vested was 30,000 shares of restricted stock. As a result of such vesting, the number of shares of unvested restricted stock is reduced by 30,000 shares and the number of shares owned directly is increased by 30,000 shares, before shares were sold to pay for taxes. Restricted stock held under 1986 SunTrust Executive Stock Plan, 1995 SunTrust Executive Stock Plan and SunTrust Banks, Inc. 2000 Stock Plan. Subject to certain vesting conditions. Restricted stock agreements contain tax withholding features allowing stock to be withheld to satisfy tax withholding obligations. All plans are exempt under Rule 16(b)-3.
- (2) This amendment reverses the vesting of 30,000 shares of phantom stock incorrectly reported on September 17, 2006. Granted in exchange for restricted stock. Will be paid out on various dates. These phantom stock units convert to common stock on a one-for-one basis.
