Elbit Systems Awarded \$17 Million Contract to Supply Electronic Warfare Systems to a European Country

Haifa, Israel, June 21, 2018 – Elbit Systems Ltd. (NASDAQ:ESLT and TASE: ESLT) ("Elbit Systems" or "the Company") announced today that it was awarded an approximately \$17 million contract from a European country to supply a range of advanced ground-based Electronic Warfare (EW) and Signal Intelligence (SIGINT) systems. The contract will be performed over a two-year period.
