ITEM 5. OTHER EVENTS

On September 4, 2001, the Company received notice from The Nasdaq Stock Market, Inc. ("Nasdaq") that its common stock failed to maintain the minimum bid price of at least \$1.00, as required by Nasdaq Marketplace Rule 4450(a)(5) ("Rule"), over a period of 30 consecutive trading days. Nasdaq has provided the Company with 90 calendar days, or until December 3, 2001, to comply with the Rule. If at any time before December 3, 2001, the bid price for the Company's common stock is at least \$1.00 for a minimum of 10 consecutive trading days, the staff of Nasdaq will determine if the Company complies with the Rule. If the Company is unable to demonstrate compliance with the Rule by December 3, 2001, the Company's common stock will be subject to delisting from Nasdaq. Any such determination of Nasdaq may be appealed by the Company to a Nasdaq Listing Qualifications Panel.
