Item 5.03 Amendments to Articles of Incorporation or Bylaws; Change in Fiscal Year.

On April 19, 2010, the Board of Directors (the “Board”) of Riviera Holdings Corporation (the “Registrant”), approved and adopted an amendment to Article III of the Registrant’s Bylaws (the “Amendment”) to provide for:

- (a) The creation of the Office of the CEO, which shall be held collectively by those officers designated by the Board.
- (b) The elimination of the requirement that the Chairman of the Board shall also be the Chief Executive Officer.
- (c) Making related conforming changes to Article III of the Registrant’s Bylaws, including the renumbering of sections.

The amendment to the Registrant’s Bylaws took effect upon adoption by the Board.
